**ROUND THREE - PHILLIP**

To be read in conjunction with the 2021 Motorsport Australia Victorian State Circuit Racing Championship Series Regulations, available from the Organisers.

**1. EVENT DESCRIPTION AND AUTHORITY**

The Event will be a **Victorian State Championship Race Meeting**, conducted at the Phillip Island Grand Prix Circuit over a lap distance of 4.45km in an anti-clockwise direction on 14th May to 16th May 2021, held under the FIA International Sporting Code including Appendices, National Competition Rules of Motorsport Australia, The Circuit Race Standing Regulations, the 2021 Motorsport Australia Victorian State Circuit Racing Championship Series Regulations, the Phillip Island Grand Prix Circuit Standing Race Regulations (Issue 05-2018), these Supplementary Regulations and any Further Regulations or instructions Issued for the Event.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st and Risk Management Policies, which can be found on the Motorsport Australia website at [www.motorsport.org.au](http://www.motorsport.org.au)  
Motorsport Australia Permit Number **321/1605/03**.

#### 5. ENTRIES

- 5.1 The details of entries for this event are listed on: -  
the preferred entry is via Motorsport Australia Event Entry-  
<https://evententry.motorsport.org.au/UpcomingEvents> or  
-the Entry Form which forms a part of these Regulations.  
Entries open on publication of these Regulations and close on 3<sup>rd</sup> May 2021.
- 5.2 Each Competitor must hold a Motorsport Australia Competition Licence unless they comply with (a) or (b) below. Each Driver must hold a minimum of a Motorsport Australia Circuit Licence with Provisional endorsement or;
- (a) hold a MotorSport New Zealand competition licence and Tasman Visa valid for the Event; or  
(b) hold a minimum of the highest grade National Licence issued by a foreign ASN together with an authorisation issued by that ASN for the Event; each such Driver and Competitor:
- (i) shall be ineligible to score points in any Championship/Cup/Series/Trophy/etc connected with the Event; and  
(ii) must receive an authorisation to compete from Motorsport Australia prior to the Event;
- 5.3 Entries will be accepted in order of receipt, until the track density for each category has been reached. The maximum number of entries will be 300 or the number determined by the Return to Race Plan for the event as it applies at the commencement of the event.
- 5.4 The Organiser confirms that the circuit to be used for this Event holds the necessary Motorsport Australia National Track licence for each of the Events nominated in these Supplementary Regulations. Entries open on publication of these Regulations and close on 3<sup>rd</sup> May 2021.
- 5.5 The preferred method of entry for this event will be via the Motorsport Australia Event Entry online system [www.evententry.motorsport.org.au](http://www.evententry.motorsport.org.au). The Entry Fee is \$495.00 (GST inclusive) for all entries. Each Entry fee also includes a \$50.00 television/streaming contribution as determined by the VSRS Executive Committee. *The full entry fee must be received before your entry can be considered as accepted.*
- 5.6. The Organisers reserve the right to accept or reject any entry without assigning a reason  
(NCR 33).

#### 6. INVITED CATEGORIES

Races will be run for cars complying with the Regulations for the following categories as described in the 2021 Motorsport Australia Victorian Circuit Racing Championships Series Regulations :-

Sports Sedans, Improved Production (including BMW E30), Sports Cars, Formula Vee, Formula Ford 1600, Formula Ford, Porsche 944 Sports Cars, MGs (including invited British Sports Cars), HQ Holdens, Group N Historic Touring Cars, Saloon Cars and Circuit Excels.

## **7. SCRUTINY**

- 7.1. Targeted Scrutiny procedures will be applied at this Event **using Motorsport Australia Return to Race Self-Scrutiny. Vehicle and Apparel Compliance Document shall be used and likewise Self Scrutiny Checklist.** Vehicle Damage reports held will be submitted with post event documentation
- 7.2. Competitors must present their appropriate Motorsport Australia Licence Card, Motorsport Australia Licence Passbook, Motorsport Australia affiliated car club membership, and vehicle logbook at Document Checking/Scrutiny Checklist. Details will be outlined in Further Regulations
- 7.3. All Driver apparel shall be in accordance with Schedule D of the current Motorsport Australia Manual of Motor Sport.

## **8. GENERAL**

- 8.1. Protests, if any, must be lodged in accordance with Part XII of the NCR.
- 8.2. The Promoter reserves the right to cancel, abandon or postpone the Event in accordance with NCR 11.
- 8.3. Fuel shall be in accordance with Schedule G of the current Motorsport Australia Manual.
- 8.4. Timing will be by electronic means and the Chief Timekeeper is deemed a Judge of Fact regarding timing.
- 8.5. Competitors must approach the Secretary of the Event for requests for changes to entry: -
  - Start from rear of grid.
  - Withdrawal of entry.
  - Change of entered vehicle.
  - Change of entered driver.
- 8.6. Judges of Fact will be named in the Official Program.

## **9. AWARDS**

Points will be awarded toward the relevant Motorsport Australia Victorian Championship/Series for each Support Race and Main Race for the relevant category, in accordance with the Motorsport Australia 2021 VSCRC Series Regulations. Awards for each race will consist of certificates supplied by the Victorian State Race Series Inc.

## **10. ALCOHOL, DRUGS AND OTHER SUBSTANCES**

Any holder of a Motorsport Australia 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the Motorsport Australia Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy as published on the Motorsport Australia website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a Motorsport Australia 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for

the presence of alcohol by a Motorsport Australia Accredited Testing Official (MSAATO) in accordance with the Motorsport Australia Standard Operating Procedure for Breath Alcohol Testing.

### **11. INSURANCE**

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the Event. Further details can be found in the Motorsport Australia Insurance Handbook, available at [www.motorsport.org.au](http://www.motorsport.org.au).

### **12. FRIDAY PRACTICE AVAILABILITY.**

The Circuit will be available for pre-event practice on Friday 14th May. The Organiser for the weekend race event is PIARC, as is the Friday. A separate Entry Form is required, a separate Entry Fee is payable to the Organisers for the Friday sessions, and if a garage is required on the Friday, a separate fee for that will be applied. Entry is Preferred via Motorsport Australia Event Entry.

### **13. COMPETITOR SUPPORT VEHICLES**

The use of motorised equipment trolleys/ tyre trolleys (or Golf buggy type vehicles) is prohibited in the Pit Lane and Paddock.
